- The academy trust must establish an audit and risk committee, appointed by the board:
  - Trusts with an annual income over £50 million must have a dedicated audit and risk committee.
  - Other trusts must either have a dedicated audit and risk committee or can combine it with another committee, such as finance [Resources].
- The remit for committees are set out in the Terms of Reference for each committee (save for First and Second committees, Headteacher/Principal's Performance Management and Pay Appeal, as the responsibility of those committees is determined by the nature of the reason the committee was called for).
- The board may also delegate functions to other committees. Each committee must contain a majority of trustees, but it may also include other people the board chooses to appoint.
